Dear Taxpayer;

On October 2nd 1995, the Board of County Commissioners adopted a resolution for the adoption of Building and Improvement Notice Regulations.

Any person desiring to construct a building on lands in the unincorporated areas for Dolores County, Colorado, must first file a building and improvement notice with Dolores County Assessor's Office. There will be a fee, which varies with the type of construction.

A building & improvement notice is required if you plan to do extensive remodeling, additions, porches, construction of sheds, barns outbuildings and new homes. If you are not sure if a building and improvement notice is required you should contact the Assessors Office at (970) 677-2385 for assistance.

If construction is started without the purchase of an improvement notice the fee will raise from \$25.00 to \$75.00 for new homes or a business and from \$10.00 to \$30.00 for other construction such as additions, remodels, garages, out buildings, hay barns etc. Failure to comply with these regulations is a Misdemeanor and will result in a fine up to \$300.00. Enclosed is a copy of the building and improvement notice. The County asks for your cooperation in the enforcement of these regulations.

Additional permitting required in the County may include but not limited too Sewage Disposal, Driveway (access road) and Floodplain Development, Information regarding these and other permits and land use regulations can be obtained from the County Commissioners Office or by calling their number (970) 677-2383."

Physical addresses are to be obtained from the County commissioners' Office at no charge Utility companies will not hookup services without a physical address.
