A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF DOLORES COUNTY AND STATE OF COLORADO AUTHORIZING PARTICIPATION IN THE RURAL JUMP-START PROGRAM ON OCTOBER 5, 2020.


