Call to Order	Gus called meeting to order at 11:04am.	Information Only
Approval of Minutes	May 11th minutes were read by Gus. Chris requested that minutes be done electronically and distributed with meeting materials. The group agreed. It is too hard to make changes or remember what happened when they are not sent out.	Motion to approve by Chris and Sonny seconded. <b>Motion Approved</b>
Financial Report	Gus presented the financials for Tammy Beanland as follows:  DCDC checking account balance as of 5/31/16 is \$27,678.63  Deposits  \$500.00 - Region 9 \$280.00 - LTJ (June rent)  Expenses \$25.00 - Chris Roberts (mileage) \$500.00 - Steve Pehrson (tractor exhibit move)  DCDC (loan fund) checking account balance as of 5/31/16 is \$19,481.10 Deposits \$553.93 - Tim Rossiter pmt  DCDC savings account balance as of 4/30/16 is \$16,365.97 No activity The Chamber account has \$475.10  Bills up for approval: Rodgers & Company for the Tax 990 forms for: DCC, Chamber and the Foundation (now the loan fund for \$50 each and totaling \$150 Ian Ferring -sewer piping—Fixed elbow by Carhart building \$815	Laura made the motion and Sonny seconded that the financial report be approved. The motion passed with all in favor.  Kendra made the motion and Chris seconded that the bills be approved for payment. The motion passed with all in favor.

River Rim Tear Drop Update	Tim provided and update on his business and his discontent about how the DCDC handled him needing to get off the board and pay off the \$6K loan he got as a board member. There was a lot of discussion as to why the DCDC had to put their house in order and the threat of an Attorney General investigation. There was recognition that we need to work with Time who has made payments on the loan but hasn't been able to pay off. If he paid it off, he would need another loan. There was discussion that paying off the \$6K amount would solve the problem.	Laura made the motion that Tim make payment to close out the current loan (the \$6K made as a board member) and apply for a new loan. He would like to be able to apply within 30 days do to ordering of equipment and current contracts. Sonny seconded the motion that passed with all in favor.
Dove Creek Chamber of Commerce	There was discussion about the Chamber being under the DCDC and making sure they are in compliance. Chris checked the Secretary of State office and we are but need to change the registered office and registered agent to DCDC. Discussion about whether checks need 2 signatures. The grant funds will stay in the DCDC account until needed by the Chamber. The DCDC will be paying for the staff person.  The Chamber will receive \$7,000 through the Challenge grant and CDC was planning to match \$1,100. In discussion regarding the Chamber budget, the Board would like to up their match to bring the budget up to \$10,000. Gus said the school provided \$701.60 for marketing that will also need to be included. There was significant discussion about the importance of the staff person and that hopefully memberships would pay for additional marketing.  Chamber materials Bryce has a ton of Chamber materials in his building. There was discussion that very few of the items would be useful today. Resources and magazine would be outdated etc. The chamber began in 2009.	Laura made the motion to increase the DCDC match to make up the difference from the Challenge grant, (and school donation of \$701.60 from checking) to meet the Chamber budget. The remaining amount will come from savings and not to exceed \$4,110. Sonny seconded the motion that passed with all in favor.  Laura will outreach Bryce about getting the bylaws and other materials and passwords for the Chamber. Gus will pick up the Chamber boxes and Laura will plan to go through them. Laura will take the "recyclables" back and determine what can still be used.
Technical Assistance Opportunity	Carolyn Dunmire submitted an application to the State's Blueprint 2.0 program for technical assistance around tourism development. The group felt it would help get the new Chamber Director up-to-speed. It is through the Office of Economic Development. Laura also offered to connect the new Chamber Director to other chambers in the region.	FYI
Website Development	DCDC received permission to get a page on the County website. Laura will be submitting that information to the County to upload. It will be basica information with Gus as the contact and the loan application materials. Laura hopes to have this done y the next meeting.  There was also discussion about the Chamber website. Laura will talk to Bryce and try to get the information so the group could possibly update it with their limited budget.	FYI Send Loan application to Tim.
