Range Rules

- A. **Anyone under the age of 18** requesting use of the Shooting Range must be accompanied and supervised by an adult at ALL TIMES.
- B. Where applicable, a Fair Board member representative may be present at any event.
- C. It is required that all members **POLICE YOUR BRASS.**
- D. It is required that all members **PICK UP ALL TARGETS AND TRASH.**
- E. It is required that all members **ENSURE THAT TRAP/SKEET EQUIPMENT IS RETURNED TO WEATHER SAFE AREA AFTER USE.**
- F. There will be **NO DOGS ALLOWED** at the Shooting Range, no exceptions.
- G. A **Fairgrounds Schedule** of prioritized events has been attached. ALL MEMBERS are required to abide by this calendar and will yield to prioritized events. The schedule may be subject to change at any time.
- H. **To reserve** the shooting range for any event, a written request must be submitted by the first Monday of every month. **Special events insurance may be required** to be purchased by member prior to event.
- I. When the Fairgrounds are rented out for a special event, members may be **required to yield to renters.**
- J. **Tracer**, armor piercing and incendiary ammunition is **prohibited**. When going downrange, stay on the walkways to and from the targets.
- K. **Only paper or cardboard** targets will be allowed at rifle range. Ground, flying, or metal targets are prohibited in this area.
- L. **Only** clay pigeons will be allowed at trap range. All other types of flying targets are prohibited.
- M. **Always** keep firearms pointed in a safe direction.
- N. **Always** keep your finger off the trigger until ready to shoot.
- O. **Always** keep your gun unloaded until you are at the firing line and the range is declared "HOT." Firearms must be safe (unloaded - magazines removed and actions opened) when entering or exiting the range.
- P. **Cease Firing:** Immediately stop shooting when anyone calls "Cease firing."
- Q. **COLD Range:** Shooters must check with others to ensure firearms are unloaded, actions open and firearms laid down on the shooting bench before going down range. No one is permitted to handle firearms or stand at the firing line while there is a cold range.
- R. **HOT Range:** Shooters must check with others to ensure there is no one down range; when the range is declared "HOT" shooters are permitted to commence firing. Only shooters are permitted on the firing line. Shooters may move safe guns to and from the firing line only when the range is "HOT."
- S. **All shooters are responsible for their rounds staying within the confines of this range.** Shooters may shoot only from the firing line at the target in line with their position. Shooting at items placed on the ground or at targets not posted at the appropriate height on the target frame enables rounds to escape the range.
- T. **Respect Yourself:** Wear eye and ear protection. Food, beverages and smoking are not allowed on the firing line. You should wash your hands and face after shooting.
- U. **Respect Others:** There is a one-hour time limit for use of the range if patrons are waiting. Be aware of farmers and neighboring residents in the area. As a caution **ALL SHOOTING WILL STOP if there is active farming in the neighboring fields.**
- V. **For Safety Reasons: Members can use the rifle range OR the trap range (both will not be allowed to be in use at the same time.)**
- W. **Members** who have visiting family may temporarily extend their Additional Family to cover any family members who may be staying with a current member.
