**PERMIT FEES:** The following permit fees are in effect for the **2001** calendar year and thereafter unless changed.

**PERMIT FEE: \$50.00**

Utility Companies, Bonded Private Contractors and Individuals:

ROAD BREACH: \$1500 per permit/per location – All gravel roads

ROAD BREACH: \$3000 per permit/per location – All Asphalt or Chip Seal Roads

ROAD BREACH USING CONCRETE: \$750.00

All permittees will be required to post a Bond or Cash Deposit for the granting of a permit except utility companies which will be subject to proof of insurance as established by the Board of Commissioners.

Utility Companies, Private Contractors and Private Individuals:

ROAD BORE – \$50.00 All Roads

Utility Companies, Private Contractors and Private Individuals:

**DRIVEWAY:**

Residential or Commercial - \$125.00 per permit/per location

All work performed from bottom of ditch to ROW - \$500.00 per mile or \$.10 per foot

All permit holders are responsible for the clean up of the County right-of-way. Permittees shall immediately repair and restore all disturbances of the road or right-of-way to current County specifications. Upon failure to do so the County may repair or restore and the permittee shall be liable to, and owe, the County for all reasonable costs and expenses incurred.

No company or person shall dig in or disturb County right-of-way without complying with the above. If there is a bona fide emergency said company or person shall deal with the emergency in an appropriate manner and comply with the above procedure on the next working day.

The County hereby reserves the right to construct or reconstruct or enlarge or alter or change or maintain or abandon the road right-of-way or other ways herein involved and permittee stipulates and agrees to same, and permittee further stipulates and agrees that at request of County and at permittee's sole expense, to alter, change, lower or otherwise adjust its ditch, pipe, conduit, line or other facilities so as to allow normal maintenance and as reasonable required for changes

construction, reconstruction, abandonment, or change of the road right-of-way or other ways.

**Maintenance-Traffic:** Permittee shall install or construct or place its ditch or other property as allowed under this Permit in such manner as not to interfere or hamper maintenance of said road or way and in the manner as may be directed, requested or required by County's Road Supervisor, and permittee shall so install, construct or place same in manner to cause minimum interference with or danger to traffic over a road or way, and shall not at any time, without prior written consent of Road Supervisor, prevent or stop traffic over a road or way for more than one hour at a time a not more than a total of one hour in any two hour period of time.

**Compliance with Law:** Further, permittee shall at all times comply with all laws of the State of Colorado in connection with such construction, installation, placing or use authorized hereunder.

Authorized by Resolution of County passed and adopted the 30<sup>th</sup> day of July, 1996, wherein the Chairman of the Board was authorized and directed to enter into and to execute on behalf of County Permit or License therefore.

The County Road Superintendent may authorize and give a Permit for crossing or tunneling across a road, or way for a line or lines, or for a pipeline without prior approval by County.
